SIRA telehealth item numbers for medical practitioners – effective 9 March 2023

This document lists the 54 telehealth item numbers for medical practitioners delivering telehealth services in the workers compensation scheme. Medical practitioners are to bill for telehealth consultations using the same AMA Fees List item number normally billed for a face-to-face consultation, with the addition of a 'T' as a suffix to the item number.

Telehealth means delivery of consultations via video or telephone. Consultations would be inclusive of any electronic communication to support the delivery of the treatment service. No additional fee (e.g. facility fees) can be charged in relation to the consultation.

Practitioners are responsible for delivering telehealth consultations in accordance with the principles of professional conduct and the relevant professional and practice guidelines to ensure that all care is taken to ensure the safety, appropriateness, and effectiveness of the service.

All medical practitioners treating workers compensation patients should refer to the *Workers Compensation (Medical Practitioner Fees) Order* current at the date services are delivered for further information.
