SIRA telehealth item numbers for medical practitioners <u>- effective 1 December 2021</u>



This document lists the 53 telehealth item numbers SIRA has introduced for medical practitioners. Medical practitioners are to bill for telehealth consultations using the same AMA Fees List item number normally billed for a face to face consultation, with the addition of a 'T' as a suffix to the item number.

Telehealth means delivery of consultations via video or telephone. Consultations would be inclusive of any electronic communication to support the delivery of the treatment service. No additional fee (e.g. facility fees) can be charged in relation to the consultation.

Practitioners are responsible for delivering telehealth consultations in accordance with the principles of professional conduct and the relevant professional and practice guidelines to ensure that all care is taken to ensure the safety, appropriateness and effectiveness of the service.

All medical practitioners treating workers compensation patients should refer to the *Workers Compensation* (Medical Practitioner Fees) Order current at the date services are delivered for further information.
